

PACIFIC SAIL & POWER BOAT SHOW EXHIBITOR'S LIABILITY INSURANCE REQUIREMENTS

Each exhibitor at the Pacific Sail & Power Boat Show is required to provide General Liability coverage from an insurance company in good standing with minimum policy limits of \$1,000,000 per occurrence and \$2,000,000 in the general aggregate.

\$1,000,000 Combined Single Limit of bodily Injury and Property Damage Liability
AND EITHER
a) \$1,000,000 Watercraft Liability, or
b) \$1,000,000 Protection and Indemnity (P&I) Coverage
